**Note:** If all of the following apply to you:

1. You were convicted of an offence that you committed when you were 17 years old or younger;
2. You were not dealt with in the Juvenile Court, i.e. the court treated you as an adult; and
3. You were found guilty of that offence five years ago or more, then:

You may be eligible to have the record of that offence spent (disregarded) now, instead of waiting for 10 years to elapse since you committed the offence. This means that in some instances, your offence will not be recorded in your criminal history. If you consider this to be the case, then the following request should be signed:

*I believe that under the Criminal Records (Spent Conviction) Act that I might be eligible to have a conviction(s) spent under the conditions listed above. Please have the Criminal History and Warrant Unit review any entries listed under my name and ensure that this record(s) is spent when it is appropriate to do so.*
